THE TKTS BOOTHS, STARTING IN 1973 WITH ONE AND AT JUNE 30, 2025, NUMBERING TWO, SELL APPROXIMATELY 630,000 SAME-DAY DISCOUNTED TICKETS ANNUALLY TO BROADWAY AND OFF-BROADWAY THEATRE AND DANCE PERFORMANCES.
